## 2022 CONTEST RULES



Please adhere to all local and state COVID-19 guidelines and precautions during in-person/group interactions when participating in this contest.

ENTRY DEADLINE: Monday, FEBRUARY 28, 2022 (by 11:59 pm):

•Electronic Registration Required on ShoutDownDrugs.com •Song and Video, Soundtrack or Instrumental, Photo, Lyrics must be uploaded when registering

### ALL CONTESTANTS MUST:

- be a **High School Student**, in Grades 9 through 12, in good standing with their school.  
(For students enrolled in a NJ high school equivalency program, please contact the program coordinator for eligibility.)
- be a **resident of New Jersey**.

Contestants can enter as an individual or a group [Groups cannot exceed six (6) students]

### SONGS MUST:

- be **completely original music and lyrics** with no copyright infringement violations.
- be no more than **3 (THREE) minutes in length**.
- contain a **strong prevention message**.

**For copyright-protected songs:** Please carefully read Paragraph 5 of the Copyright License, Assignment & Talent Release before entering the contest.

\*All music genres are welcomed – Rock, jazz, R&B, hip hop, gospel, etc.

### MUSIC/LYRICS/PHOTO/VIDEO

- **TWO VERSIONS** of your song must be submitted:  
One version must contain **music and all vocals**.  
One version must contain **music only** (soundtrack or instrumental, with background vocals if any).
- **TYPED LYRICS** with a song title, must be copied and pasted into designated lyric field on the upload site.
- **PHOTO:** Be as creative as you like, but you must follow copyright rules. (Groups: one group photo only). PDFNJ reserves the right to reject any inappropriate images.
- **VIDEOS** will also be accepted, in addition to the recorded music. Please note if you choose not to submit a video, your recorded song will be played in place of a video, including during the Virtual Prevention Concert, if chosen as a finalist.

**The above must be uploaded when registering** (for groups, only group leader uploads the music, lyrics, photo and video). Follow uploading instructions on [ShoutDownDrugs.com/register](https://ShoutDownDrugs.com/register).

### REGISTRATION

**Step 1:** Registration must be completed and submitted electronically [ShoutDownDrugs.com/register](https://ShoutDownDrugs.com/register).  
**GROUPS; each group member must submit their own individual registration.**

If under the age of 18, registration must be submitted by parent or legal guardian. If **over** the age of 18 proof of age must be submitted to Diane@DrugfreeNJ.org (copy of **birth certificate** or **driver's license**).

**Step 2:** Recorded Song, Soundtrack/Instrumental, Photo, Lyrics and Video must be uploaded at the time of registering.  
(for groups, only group leader submits Step 2)

### CONCERT

The 2022 PREVENTION CONCERT will be a pre-recorded virtual event. The event will feature the contest finalists' music videos (or a recording if a video is not submitted). The First, Second and Third Place Winners will be announced at the conclusion of the event.

**Groups:** No substitutions are allowed for any group member who withdraws from the contest, but remaining group members may continue with the contest but must contact the program coordinator first for permission.

## 2022 CONTEST RULES – p2

### JUDGING

- Independent panels of judges will select County Finalists and First, Second and Third Place Winners. Finalists will be featured in the Virtual Prevention Concert. First, Second and Third Place Winners will be announced at the conclusion of the Concert.
- Judges will select County Finalists from each of New Jersey's 21 participating counties; however, PDFNJ reserves the right to select additional "Wildcard" Finalists.
- Participants will represent the county where they reside, not where they attend school. (*For group entries, the group leader's residing county is the group's official county of entry.*)
- **Online Voting:**
  - All Entries (selected by judges) will be posted on ShoutDownDrugs.com for a two-week online judging period.
    - Contestant with most online votes becomes **Automatic Finalist!**
  - All Finalists will be featured up until the Prevention Concert
    - Finalists' total online votes will be combined with Judges' scores to help select 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> Place Winners.

#### **Finalists Will Be Announced at Conclusion of First Round of Online Voting on ShoutDownDrugs.com and DrugFreeNJ.org:**

- Each Finalist will be featured in Virtual Prevention Concert.
- First, Second and Third Place Winners will be announced at the conclusion of the Virtual Prevention Concert, live on air on 95.9FM WRAT Radio and WRAT.com.
- All decisions are final.

### JUDGING CRITERIA ~ *Emphasis will be placed on your Prevention Message* ~

#### 1. Prevention Message/Lyrics:

- Is the message clear?
- Does the song inform peers about the dangers of substance misuse and abuse?

#### 2. Originality:

- Does the song motivate and inspire peers to be drug-free?
- Does it connect teens to the message of the dangers of substance misuse and abuse?

### PRIZES

#### First Place Winner (*individual or group*)

- will be awarded a \$5,000 "Music Contract"
- will be required to perform their winning song at three (3) separate events\*, which shall be determined at a future date. These may include virtual events. Prize will be distributed in accordance with the terms of the music contract and contingent on performance at scheduled PDFNJ events.

#### Second Place Winner (*individual or group*)

- will be awarded a \$3,000 "Music Contract"
- will be required to perform their winning song at two (2) separate events\*, which shall be determined at a future date. These may include virtual events. Prize will be distributed in accordance with the terms of the music contract and contingent on performance at scheduled PDFNJ events.

#### Third Place Winner (*individual or group*)

- will be awarded a \$2,000 "Music Contract"
- will be required to perform their winning song at one (1) event\*, which shall be determined at a future date. This may be a virtual event. Prize will be distributed in accordance with the terms of the music contract and contingent on performance at a scheduled PDFNJ event.

\*Winners are responsible for their own transportation to any in-person event and minors must be accompanied by a chaperone 21 or older. PLEASE NOTE, if a group is chosen as the 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> Place Winner, the prize money will be divided equally among group members.

### EXCLUSIONS

Contest is **not open to past Your Song! Your Voice!® NJ Shout Down Drugs® Winners** but other past contestants may enter. Contest is not open to employees and immediate family members of PDFNJ, nor any Sponsor of this contest. PDFNJ reserves the right to reject any entry that goes against its mission.
